

## TERMS AND CONDITIONS FOR DISPOSAL OF CONDEMNED VEHICLES & ITEMS

1. The Commissioner, Municipal Corporation Mandi, H.P. intends to dispose of condemned vehicles/items through Public Auction (Open Boli) on "AS IS WHERE IS BASIS".
2. The Public Auction (Open Boli) shall be conducted on the date, time and place as mentioned in the Public Auction Notice.
3. The disposal of vehicles/items shall be strictly on "AS IS WHERE IS BASIS" and no guarantee or warranty regarding quality, condition or roadworthiness of the vehicles shall be given by the Municipal Corporation Mandi.
4. The vehicles proposed for auction may be inspected by interested bidders from 06.01.2026 to 12.01.2026 at Town Hall, Municipal Corporation Mandi & Govind Ghat, Mandi on any working day during office hours.
5. Each bidder shall deposit an Earnest Money Deposit (EMD) as mentioned in Auction Notice per vehicle, in the form of Demand Draft drawn in favour of Commissioner, Municipal Corporation Mandi, prior to participation in the Public Auction. Bidders without EMD shall not be allowed to participate.
6. The Public Auction (Open Boli) for each vehicle shall start from as mentioned in Auction Notice.
7. The highest bidder shall be declared successful, subject to approval of the competent authority.
8. The successful bidder shall deposit the entire bid amount through Demand Draft in favour of Commissioner, Municipal Corporation Mandi within three (03) working days from the date of auction, failing which the EMD shall stand forfeited and the bid cancelled.
9. The EMD of the successful bidder shall be adjusted against the sale amount after realization of full bid amount. EMD of bidders who fail to honour the bid shall be forfeited. No representation in this regard shall be entertained.
10. Delivery of the sold vehicle shall be allowed only after submission of valid identity and residence proof (Aadhaar Card / Voter ID / Ration Card in case of individuals and Registration Certificate in case of firms).
11. The successful bidder shall remove the sold vehicle(s) within 48 hours of depositing the sale amount at his/her own cost. No transportation or assistance shall be provided by Municipal Corporation Mandi. Removal of vehicles shall not be allowed on Sundays or Gazetted holidays.
12. The successful bidder shall be solely responsible for transfer of Registration Certificate (RC) of the vehicle(s) in his/her name at his/her own cost (if applicable). Municipal Corporation Mandi shall not be responsible for any delay or lapse.
13. The existing registration number of the vehicle shall be retained by Municipal Corporation Mandi and shall not be transferred. The successful bidder shall apply for a new registration number as per provisions of the Motor Vehicles Act, 1988, at his/her own cost (if required).

14. The Commissioner, Municipal Corporation Mandi, H.P. reserves the right to accept or reject any or all bids, wholly or partly, without assigning any reason.
15. EMD of unsuccessful bidders shall be returned within three weeks of completion of the Public Auction.
16. Bidders shall disclose their full name, father's name, complete postal address, telephone/mobile number before participation in the Public Auction.
17. In case the highest bidder fails to honour the bid, the bid shall be cancelled and EMD forfeited. The vehicle may be re-auctioned or offered to the next highest bidder, as decided by the competent authority.
18. Any dispute arising out of this Public Auction shall be subject to jurisdiction of Courts at Mandi only.
19. The decision of the Commissioner, Municipal Corporation Mandi shall be final and binding in all matters relating to the Public Auction.
